## Whole Farm Revenue Protection Coming This Spring!

This plan of insurance allows you to insure your cash crops, specialty crops, livestock, organics, fruits and vegetables that may not have had coverage available in the past.

- Provides protection against loss of farm revenue due to unavoidable natural causes.
- One policy protects your income and may replace multiple policies.
- Coverage levels range from 50-85%.
- Replaces AGR and AGR-Lite program and is available in all Michigan counties.
- May be bought alone or combined with other buy-up level Federal crop policies if you choose; however, not available for a single commodity that is already covered by a Federal crop policy.

WHAT'S NEEDED FROM THE FARMER

Five years of IRS-Schedule F.  
Some levels may require  
at least three commodities.
